FLAG DAY PARADE WAVES ON FOR 29 YEARS

On June 9, the Anaheim Flag Day Committee hosted the 29th annual Anaheim Flag Day Celebration. Sally Feldhaus has been the chairwoman and driving force behind the Patriotic celebration for 29 years and it evolved into a beloved annual event. Flag Day, celebrated on June 14th, carries immense significance as it commemorates the adoption of the American flag in 1777 by the Continental Congress. As Sally Feldhaus said, "We celebrate Flag Day because it is crucial for future generations to comprehend the flag's symbolism and the historical context in which it was adopted, as it represents the cornerstone of our nation's heritage."

The celebration was held on Sunday June 9, at Pearson's Park in Anaheim and began at 11:30 am. A red, white, and blue patriotic parade, with 53 entries from around Orange County that included floats, walking units, and 9 antique Model T Ford vehicles. The Parade Grand Marshall is always the United States Flag and special guest appearances were troops representing Combat Logistics Battalion 13-Camp Pendleton, Coast Guard Auxiliary, ROTC Orange High School Color Guard and Southeast County Young Marines. A patriotic feature was a walk through the "Avenue of Flags" which represents patriotism, national pride, and a visible, bold, and proud display of flags.

Riding in the parade was Congressman Lou Correa, Anaheim Mayor Ashleigh Aikens, Anaheim City Council Members and State Senator Tom Umberg who gave a special "Certificate of Recognition" to Feldhaus and the Anaheim Flag Day Committee for their patriotism and dedication.

The stage entertainment started off with the Pledge of Allegiance led by Rudy Lopez, Commander of the U.S. Coast Guard Auxiliary and the National Anthem was sung by Girl Scout, Shey Tiettmeyer. A solemn "Folding of the Flag" ceremony was presented by the Southeast County Young Marines. Everyone enjoyed the free ice cream and cake provided by the Committee while listening to singer-songwriter and hometown star Sean Oliu.

The event was organized by the Anaheim Flag Day Committee, a group of dedicated community volunteers that include Sally Feldhaus, Jim and Lori Dinwiddie, Susan and Steve Faessel, Bryan Flores, Bob Garoutte, Debbie Herman, Jim and Doreen Job, Gina Wilson, and Agar Yanulaytis. The official photographer was Todd Herczeg.

In addition to immersive artistic experiences, the Sawdust Art Festival offers a feast for the senses with the

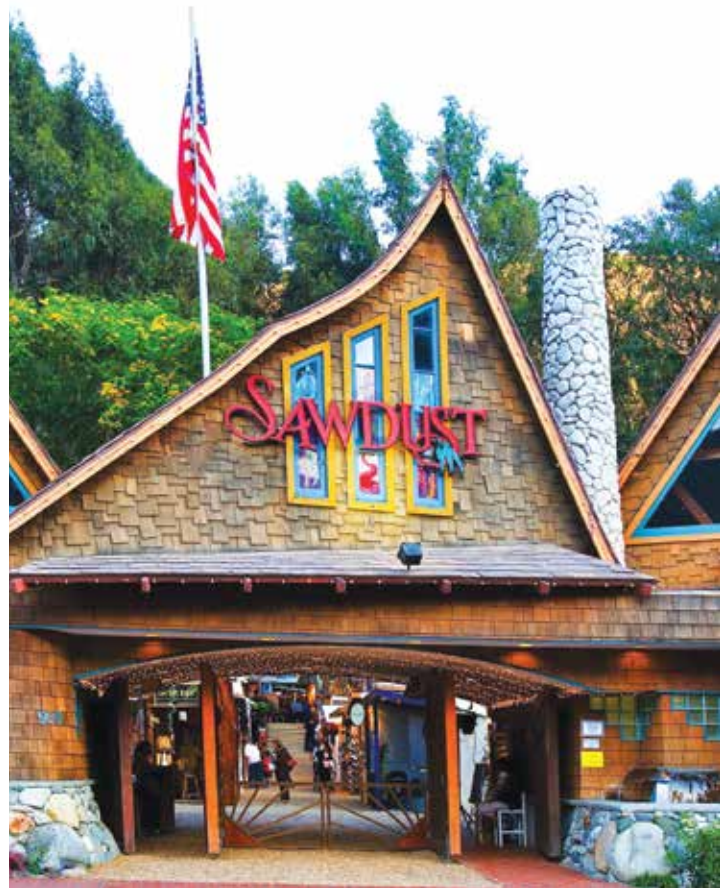

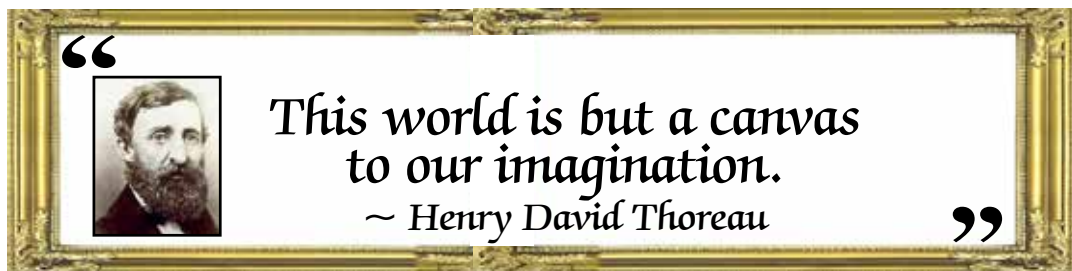

Taste of Wine & Food

SAVORING THE BEAUTY, WINES OF ANTINORI NAPA VALLEY

Having recently attended an Antinori Wine Dinner at The Butcher Shop, when my recent vacay led me to Napa Valley, I wanted to experience Antinori Napa Valley in addition to the Antinori Italian wines I have previously tried.

Antinori Napa Valley (ANV) represents a landmark achievement for the Antinori Family, whose winemaking legacy spans over six centuries and 27 generations. Applying their Old-World heritage and knowledge, the family has created New-World wines of finesse and refinement from their 1,200-acre mountain estate. Marchese Piero Antinori's dream of Napa Valley winemaking began in the 1960s and took shape over the years with the acquisition of high-elevation terrain in the Vaca Mountain range. The unique landscape, reminiscent of his Chianti Classico home, required years of study and continues to be an ongoing pursuit to craft the best expression of these wines. The vineyards, perched 1,600 feet above the valley floor, benefit from the ideal southwest-facing gradient and a cooling influence from the San Francisco Bay, resulting in complex, multi-layered Cabernet Sauvignon, Cabernet Franc, and Chardonnay wines of elegance and nuance. "Te Duce Proficio," meaning "Following your guide, I flourish," exemplifies their philosophy and dedication. In fact, ANV's Proficio label is the only one that bears Marchese Piero Antinori's signature.

ANV Estate Manager, Glenn Salva, provided a VIP tour of the property including their new hospitality center/tasting room, grounds, and wine caves. Salva was originally studying to be an engineer in upper state New York, noticed a viticultural magazine one late night when burning the midnight oil. He decided in the wee hours of that morning that wine was his calling and never looked back after shifting his major to viticulture/enology. Marchese hired Salva in 1986 to oversee all aspects of ANV. Over his 38 years, Salva was the epicenter of ANV and a huge part of its success with projects including oversight of the initial planting in 1986 to digging out their wine caves when the go-to Napa Valley wine cave specialists were tied up with another winery. Salva purchased mining equipment from a New Mexico mining company that was shutting down, shipped the equipment to Napa, and figured out how to build caves into a volcanic mountain. During our cave tour, Salva shared, "State-of-the-art fermentation tanks are wider at

the bottom allowing the lees cap to be pushed down and the juice to flow up the sides and over the cap. This provides gentle stirring during fermentation enhancing flavor and structure."

Our tasting started with 2022 A26 Chardonnay. A for Antinori and 26 for the generation of Marchese's daughters, Albiara, Allegra, and Alessia, who share stewardship of Antinori with Marchese. The Chardonnay was bright, fruit forward with stone fruit on the palate along with peach and pear and a hint of oak. The Chardonnay is grown next to a pond that provides a sink of cool air bestowing brightness and acidity into the fruit. The second wine was 2021 Townsend named after neighbor, June Townsend, who sold her connecting 40-acre parcel to Marchese in 1998 of which 24 acres is planted. The parcel was planted with Cabernet Sauvignon in 1999 and proved to be one of the best blocks of Cabernet Sauvignon throughout the estate using the findings of the Chianti Classico 2000 Project. The project focused on the ecological value of grape varieties to be planted, rootstock characteristics, vine density, vine training and row azimuth angles, soil management including cover crops, and clonal selection. Together these were named the X-Factor principles and used for all ANV plantings after 2000. The third pouring was 2021 Cab Franc. While ANV was planted with Cab Franc in 1987, it was not until the early 2000's with the arrival of French clones that ANV Cab Franc was super charged.

The French clones created perfumed aromatics, robust tannin structure, and supple intensity. The fourth pouring was 2021 Proficio. Proficio is the culmination of over 30 years of studying Atlas Peak. It embodies the pinnacle of quality and expression provided by ANV's steepest and rockiest mountainside vineyards. It is dominated by Cabernet Sauvignon and blended with Cab Franc for additional layers of structure. High end phenolics created a deep purple opaque color. This was an outstanding wine with plum on the palate, layers of complexity, and ultra silky tannins. Additionally, the charcuterie during the tasting was hand selected for each of the four tastings.

In closing Salva shared, "Antinori's DNA is embodied in Passion, Persistence, Perseverance, and Patience with respect for tradition and an eye for innovation." Learn more about ANV at antinorinapavalley.com.

The Butcher Shop Antinori Wine Dinner

The main course of Exec Chef Brian

Gist's five course dinner was Braciolo, an Italian roulade with breadcrumbs, cheese, and herbs, along with creamy polenta, and a red wine reduction/braising gravy. This was expertly paired with Antinori Super Tuscan Tignanello, the only other bottle of Antinori wine with a signature.

Marchese Piero decided to have his father, Niccolò Antinori, sign the label as a sign of recognition for his father's confidence in him. Marchese's creation of Super Tuscan wine was marketing

genius. Initially Tignanello was rated as 'Indicazione Geografica Tipica,' a rating created in 1992. IGTs were intended to provide a tier above the basic Vino da Tavola (VdT) aka table wine, for quality wines that didn't meet the regulations for DOC or DOCG. The Super Tuscan moniker allowed high end IGT wines blended in Bordeaux fashion to be a cut above IGT and compete directly with Italian premium DOC and DOCG wines that Super Tuscans were not compliant with.

Once your vegetables are cooked, combine them with your cooked beef and keep to the side until your sauce is ready.

In a separate bowl, start making your sauce by combining a one-quarter cup of soy sauce, a tablespoon of hoisin sauce, half a teaspoon of sesame oil, a tablespoon of your minced garlic and ginger, one-quarter cup of beef stock,



two tablespoons of dark brown sugar, and half a tablespoon of cornstarch, which will help thicken your sauce.

Add your sauce to a large saucepan over medium heat and let it simmer for one to two minutes, stirring consistently. Once your sauce has thickened, add your cooked vegetables and steak to your pan and combine. Plate your stir fry over a bowl of rice, garnish with chopped green onions, cilantro, and a squeeze of lime juice, and enjoy!

These are just four wonderful reasons to fall in love with homegrown produce. This season and beyond, embrace the green goodness of growing a produce aisle right in your backyard. Happy gardening! (BPT)

In medium bowl, combine 350 grams warm water, 150 grams sourdough

starter and 10 grams salt. Stir well then add 500 grams flour, 50 grams cocoa powder and 50 grams sugar. Using silicone spoon, mix dough to sticky ball. Let rest, covered, about 45 minutes.

Pull dough from bottom and stretch to top of dough ball. Repeat around entirety of dough ball a few times, adding 1 1/2 cups milk chocolate chips during process, then cover. Repeat process four times then cover and let sit at room temperature at least 6 hours but no more than 14 hours. Dough should double.

Sprinkle flour on counter then spread dough flat on floured surface. Fold dough from sides then turn and roll into ball. Place on parchment paper and put back in bowl 1 hour.

Heat oven to 450 F with uncovered Dutch oven inside. Using sharp knife, score dough then place parchment paper and dough in Dutch oven. Cover with lid and bake 40 minutes. Internal temperature should reach 195-205 F. Let rest at least 1 hour before cutting and serving.

Sourdough Starter

Recipe courtesy of "Cookin' Savvy"
Total time: 7 days

- Digital kitchen scale
- Unbleached all-purpose flour
- Warm water
- Glass bowl
- Silicone spoon
- Mason jar

Day 1: In glass bowl, stir 50 grams flour and 50 grams warm water. Let sit at room temperature, covered.

Day 2: Add 50 grams flour and 50 grams warm water to bowl. Stir and let sit at room temperature, covered.

Day 3: Discard half the starter. Add 100 grams flour and 100 grams warm water. Stir and let sit at room temperature, covered.

Day 4: Discard half the starter. Add 150 grams flour and 150 grams warm water. Stir and let sit at room temperature, covered.

Day 5: Discard half the starter then pour remaining starter into Mason jar. Add 150 grams flour and 150 grams warm water. Stir and let sit at room temperature, covered.

Day 6: Discard half the starter. Add 200 grams flour and 200 grams warm water. Stir and let sit at room temperature, covered.

Day 7: Place warm water in bowl and add spoonful of starter to water. If it floats, it's ready to make bread. If it sinks, repeat Day 6 instructions. If not floating by Day 10, throw out and start over.

Tips: If making bread every day, starter will need fed every day. If not making bread every day, starter can stay at room temperature and be fed every other day. If starter can't be fed, it can be safely stored in refrigerator up to 10 days, covered, without feeding.

To measure correctly, place empty bowl on scale then clear to zero before each measurement.

Pull dough from bottom and stretch to top of dough ball. Repeat around entirety of dough ball a few times then cover. Repeat process four times then cover and let sit at room temperature at least 6 hours but no more than 14 hours. Dough should double.

In bowl, mix 4 tablespoons butter, 1/2 cup brown sugar and 2 tablespoons cinnamon.

Sprinkle flour on counter then spread dough flat on floured surface. Spread cinnamon mixture on dough. Fold dough from sides, pinching to keep cinnamon inside, then turn and roll into ball. Place on parchment paper and put back in bowl 1 hour.

Heat oven to 475 F with uncovered Dutch oven inside.

Using sharp knife, score dough then place parchment paper and dough in Dutch oven lined with aluminum foil. Cover with lid and bake 20 minutes then remove lid and lower temperature to 450 F for 25 minutes. Internal temperature should reach 195-205 F. Let rest at least 1 hour before cutting and serving.

Everything Loaf

- Medium bowl
- Warm water
- Sourdough starter
- Salt
- Unbleached all-purpose flour
- Silicone spoon
- Everything bagel seasoning
- Sharp knife

In medium bowl, combine 330 grams warm water, 90 grams sourdough starter and 10 grams salt. Stir well then add 525 grams flour. Using silicone spoon, mix dough to sticky ball. Let rest, covered, about 45 minutes.
